As President of the New York Aviation Management Association (NYAMA), I wish to express strong support for retaining provisions in the Senate Transportation-HUD Appropriations Bill that would dramatically improve aviation infrastructure across the country by modernizing the Passenger Facility Charge (PFC) user fee on originating flights and increasing funding for the Airport Improvement Program (AIP) in the final FY18 omnibus bill.
